






- Number of deals was consistent throughout the year despite a slight drop during the summer months









VALUATION AS A FUNCTION OF GROWTH + PROFITABILITY




Revenue Growth + EBITDA Margin






OPERATING EFFICIENCY AND RECURRING REVENUE AS VALUE DRIVERS

Recurring Revenue Multiples









