



Q3 2018 Transactions by Subsector






Talent Development: HR software providing the means to train and develop an effective workforce **Compensation and Benefits:** HR software relating the management of employee compensation and benefits administration

Talent Attraction: Tools to help employers recruit new staff and to help prospective employees search for jobs






- Q3 2018 saw cross-border deals continue to gain momentum despite only a modest increase
- The majority of deals in Q3 were US-US, reflecting the maturity of the HR Tech market in the country relative to other regions globally

- The number of deals continues to increase quarter-on-quarter
- Again, the Workforce Management and Talent Attraction sectors proved most active but Compensation and Benefits-related acquisitions also proved popular in Q3






















EV/EBITDA CY18E



Note: Bubble size depicts enterprise value




Revenue Multiples




EV/Revenue CY18E

EBITDA Margin Analysis




